# **CHAPTER-I**

## **ADMISSION POLICY**

### **1      Introduction**

The MNR University (MNRU), Fasalwadi, Sangareddy, Telangana is the result of the dedicated efforts with commitment and values in quality higher education which have been the strengths of the MNR Educational Trust (MNRET) since 1974. It has promoted a string of educational institutions with more than 42000 students pursuing their educational careers at MNR Group of Educational Institutions, making it a premier educational group in the country. The MNRET is the Sponsoring Body for MNR University. The MNR University is established by the the Telangana State Private Universities (Establishment and Regulation) Act No 11 of 2018 (amended in 2024) Dated on 30.07.2024. The MNR Higher Education & Research Academy (MNR-HERA) is governed by the MNRET and is built on a campus at Fasalwadi, Sangareddy spread over 110 acres with aesthetic touch and eco-friendly environment make this campus best place for students to pursue studies. The MNRU is situated in the MNR-HERA campus at Fasalwadi-502294, Gr Hyderabad, Sangareddy District, Telangana State which has the state-of-the-art infrastructure and buildings housing Medical, Dental, Homeopathy Colleges & Teaching Hospitals, Pharmacy, Physiotherapy, Nursing, Paramedical, Education, and Engineering Colleges with hostel buildings for Girls & Boys.

The MNRU with its strong Foundation built up by the MNRET is now all set to become a 21<sup>st</sup> Century world-class overall higher education and skill capabilities provider to meet the Global challenges. The MNRU is a multi-institutional and multi-disciplinary university making curriculum more inclusive and offering skilful education for increasing employability potential of the graduates and postgraduates. In tune with the National Educational Policy (NEP), the MNRU will aim to develop good, thoughtful, well rounded and creative individuals with ethical and constitutional values, intellectual curiosity, scientific temper and spirit of service, given the 21<sup>st</sup> Century requirements. In the process, new courses which bring a paradigm shift from traditional technologies to the cutting edge technologies are being introduced. Apart from Degree courses, certain 3-month certificate courses and one-year PG Diploma courses as some kind of finishing schools are contemplated for enhancing the employability of the students.

The courses on Artificial Intelligence, Data Science, Machine Learning, IoT, Analog Design and VLSI under the School of Engineering & Technology and Artificial Intelligence. The University will eventually focus on research and innovation by setting up start-up incubation centers, for research in frontier technologies, greater industry-academic linkages and interdisciplinary and multidisciplinary research approaches. Given the lessons learnt from the times of epidemics and pandemics, the University

will take the lead to undertake education and research in areas of health care technologies like medical lab technologies, image technologies, emergency medical technology, virology, diagnostics, instrumentation, and other relevant areas under the School of Clinical Research, Medical and Health Sciences. The campus also has a full-fledged communication centre, conference hall, 1400 seat auditorium, canteen & dining halls, vast play grounds and an administration block.

The Student Admission Policy of MNR University has been prepared to benefit the students in understanding entire gamut of admission process being adopted in the University system. The policy includes not only Admission criteria but also contains various other important points including Refund Policy that needs to be understood and followed meticulously.

## **2 Scope and Aims of the Policy**

- 2.1 MNR University adopts a uniform policy for admissions based on merit without any discrimination and open to all persons of either sex, caste, creed, race or class. The University maintains an All- India character and high standards of teaching and research and provide merit based admission in a fair and transparent manner. Admissions to various courses shall be open to Indian citizens, Non-Resident Indians, Persons of Indian Origin. The University shall also admit foreign students as per the Government of India and State Government guidelines.
- 2.2 To provide a uniform, transparent and sustained admission policy for the benefit of all stakeholders and for maintaining inclusion and equity. The admissions are done in a transparent manner and on merit basis only.
- 2.3 MNR University is committed to provide quality higher education with global standards with scope for improvement on a constant basis.
- 2.4 To create enabling environment for joint research projects and Memorandums of Understanding (MoUs) for exchange of students and staff with international universities.
- 2.5 To implement the relevant provisions and guidelines of the National Education Policy (NEP) 2020 for Quality Higher Education.
- 2.6 The admissions policy applies to all admissions under MNR University and is subject to review annually.
- 2.7 The admission policy is compliant with all appropriate norms and guidelines of national bodies and councils.
- 2.8 The specification of titles, eligibility criteria and duration of Degree programs shall be as per the specifications of degrees prescribed in UGC Regulations or other Regularity Bodies.

### **5      University Knowledge Centre (Central Library)**

The University campus has a well-equipped Central Library also known as MNR Knowledge Center spread over **3685** square meters area, with Separate AC rooms, exclusively for PGs and teaching staff. The main aim of the central library is to provide and disseminate all health sciences information to students, faculty, and research scholars of the constituent Schools of the University. The state-of-the-art central library

is the domain for information seekers, be it students, faculty, or researchers. This facility was inaugurated by Bharat Rathna Prof. A.P.J Abdul Kalam, Former President of India on 16<sup>th</sup> August 2007.

The Library caters to the information needs of approximately 1000 users of University Campus providing access to various International and National Journals of different specialties. It has a separate Virtual classroom with 120 seating capacity for conducting academic activities like CME & CD programs and several guest lectures and video conferences are conducted here. Along with all these facilities, a separate IT zone is provided for accessing e-resources with 40 nodes and a high-speed Wi-Fi facility.

Apart from the central library, each department has a separate library focusing on subject-related books and e-library collections. The Library has over **38,575** volumes (Medical, Dental, Physiotherapy, Homoeopathy, and other related General books) classified textbooks, reference.

## **6 Scholarships and Awards**

- 6.1 Merit Scholarships are offered to motivate the young talented students in the form of Fee Concession and need-based financial assistance to the economically disadvantaged students.
- 6.2 Approximately 20 to 80 % fee concession will be given for first year admitted top rank/marks holders in the qualifying examination subject to changes as may be decided by the University every year. Further details and rules of eligibility for continuation of the scholarship in the subsequent semesters of the programmes will be issued by the University at the time of admission notification every year.
- 6.3 Students are eligible for MNRU Merit Scholarships subject to the above conditions

## **7 Admission procedure for domestic candidates**

- 7.1 Advertisement will be given regarding the registration and application and important dates etc., in all leading newspapers all over India and notified in the MNRU website.
- 7.2 Student fills the Enquiry Form with basic details and after verification of mobile and email, a link will be sent to the registered mobile/mail for Registration. Filled in Registration form along with uploaded documents will be submitted online with payment of application/registration fee through net banking or UPI
- 7.3 The admission will be purely on the basis of the marks in the qualifying examination or the rank secured in the state level test or national level test or any other prescribed test. Submission of application or payment of application fee does not guarantee the admission to the courses offered by the University. It is the sole discretion of the Admission Committee to offer Admission based on merit and counselling.

- 7.4 Result will be published in MNRU website or informed telephonically and by mail.
- 7.5 The candidates will be short-listed based on their marks or rank and will be called for the counseling.
- 7.6 The eligible candidates will be called for counselling in batches and allotment of courses on the basis of the marks or rank.
- 7.7 Physical verification of original documents by the office of concerned School.
- 7.8 Online **Provisional Admission** approval from the Dean of the concerned School.
- 7.9 Link sent to the provisionally admitted candidate for payment of fees on line or payment can be made offline at Central Fees Collection Centre at the University Campus.
- 7.10 Confirmation of the **Admission** by the Dean of the concerned School by issuing the letter of admittance or Email on receipt of total fee for the course.
- 7.11 Orientation programme for students along with their parents. Announcement of Date of Commencement of Classes and Announcement of Time Table.
- 7.12 Commencement of classes.

## **8 Eligibility Criteria - School wise and Course wise**

The eligibility criteria for admission into various UG and PG programmes of the university will be informed in the admission notification every year subject to change from year to year based on the guidelines issued by the state government or regulatory bodies/councils from time to time. The eligibility criteria for academic Year 2024-25 is given below

### **Eligibility Criteria for the AY 2024-2025**

- 8.1 MNRU School of Engineering & Technology and Artificial Intelligence**
  - 8.1.1 For all B. Tech (Hons) Courses of 4 years duration:** Candidates must have passed in the qualifying examination at 10+2 System /Intermediate level/Equivalent examination with MPC group and admission is through marks in Qualifying Examination or TG EAPCET or any State Level Entrance Test or National Level Entrance Test or any other Equivalent International Qualification or Test based on Merit. Candidates must have completed 16 years of age as on 31st December of the year of admission.
  - 8.1.2 The following eligibility criteria for the admission of lateral entry students into II Year B.Tech (Hons) courses have been discussed.**
    - a. They should be of Indian Nationality.
    - b. They should have obtained a Diploma in Engineering and Technology from the State Board of Technical Education of Telangana / Andhra Pradesh or any other Diploma recognized by the

Government of Telangana as equivalent there to with 45% marks for admission into the relevant B.Tech (Hons) course.

(OR)

They should have passed the 3-year B.Sc. Degree with 45 % marks with Mathematics as one of the subjects in the group combination from a recognized University in the Telangana / Andhra Pradesh state or its equivalent for entry into relevant courses.

- c. Candidates who are pursuing a Diploma course under sandwich pattern shall be eligible for entry into the relevant B.Tech (Hons) courses provided they have completed the practical training for the sandwich course before completion of counseling for Admissions.
- d. Candidates should have passed Diploma in Engineering / Technology or B.Sc. (Mathematics) Degree as the case may be with at least 45% marks.

## **8.2 MNRU School of Clinical Research, Medical and Health Sciences**

**8.2.1 For all B.Sc (Hons) Courses of 4 years duration:** Candidates must have passed in the qualifying examination at 10+2 System /Intermediate level/Equivalent examination with BiPC/MPC group or 10th + Diploma ( 2 or 3 Years in the relevant technology) from any recognized Board or Institute or University and admission is through marks in Qualifying Examination or any State Level Entrance Test or National Level Entrance Test or any other Equivalent International Qualification or Test based on Merit. Candidates must have completed 17 years of age as on 31 December of the year of admission.

**8.2.2 For all M.Sc (Medical) Courses of 3 years duration:** The candidate must be having an aggregate of 55% or above in graduation in a Biological Sciences stream from a recognized university.

MBBS / BDS / BAMS / BHMS / BUMS / B. Pharma / B.Sc. Life Sciences / B.Sc. Biology /B.Sc. Bio Chemistry / B.Sc. Nursing / BMLT / BPT / B. Tech. (Bio-Tech.)

## **8.3 MNRU School of Physiotherapy**

**8.3.1 For B.P.T course of 4 ½ years duration (including 6 months internship):** Candidates must have passed in the qualifying examination at 10+2 level/Intermediate/Equivalent or any other equivalent International Qualifying examination with Biology, Physics and Chemistry (BiPC). The candidates must have completed 17 years of age.

**8.3.2 For M.P.T course of 2 years duration:** Candidates must have passed in the qualifying examination of B.P.T.

## **9 Admission Procedure For NRI/PIO/Foreign candidates**

Subject to fulfilment of the norms and eligibility criteria related to Foreign/PIO/NRI students as may be specified by the Government from time to time, the MNR University invites applications for courses being offered by its Schools from NRI/PIO/Foreign candidates. Candidates should fulfill the following additional eligibility criteria to seek admission.

### **9.1 For B.Tech (Hons) and BPT?**

- 9.1.1 English as one the subjects in the qualifying Examination.
- 9.1.2 Candidates must have completed 16 years of age for B.Tech (Hons) and 17 Years of age for BPT as on 31<sup>st</sup> December of the year of admission.
- 9.1.3 For candidates having NRI status, the Sponsorship should be given only by the parent (either father or mother only) living abroad (Sponsorship by a relative/friend is not acceptable).
- 9.1.4 NRI candidates should produce in original Employer Certificate of the sponsoring Organization.
- 9.1.5 Valid Passport and Visa copies (for entire duration of the course) and copy of the National Identity card if applicable.

### **9.2 For all B.Sc. (Hons) Courses under Allied Health Sciences**

- 9.2.1 English as one the subjects in the qualifying Examination.
- 9.2.2 Candidates must have completed 17 years of age as on 31 December of the year of admission.
- 9.2.3 For candidates having NRI status, the Sponsorship should be given only by the parent (either father or mother ONLY) living abroad (Sponsorship by a relative/friend is not acceptable).
- 9.2.4 NRI candidates should produce Employer Certificate of the sponsor either of father or mother.
- 9.2.5 Valid Passport and Visa copies and National Identity card.

## **10 Domicile Based Reservation**

- 10.1 The University reserves 25% of seats for admissions in the courses exclusively for the students of the State of Telangana on the basis of domicile as per the provisions in Section 33 of the Principal Act. The Students studied for at least 2 years in the State of Telangana are eligible.
- 10.2 Children whose parent/parents born or worked at least for two years in the State of Telangana shall be treated as Students of Telangana for this purpose. Provided that the vacant seats shall be open to General Category.

## **11 Advance Payments**

The University will notify the amount of advance payment to be made by the candidate at the time of Provisional Admission in the website under “Admission Notification for the Academic Year”.

## **13 Fee Structure**

University may announce the Fee Structure from time to time and also may modify the same from time to time by issuing the circular for various courses based on the recommendations of the Fee Fixation Committee (FFC) as per the provisions in Section 32 (3) of the Principal Act after approval from the Governing Body with ratification by Sponsoring Body. The University may also award fee waivers to the students and research scholars in accordance with the decision of the Board of Management duly approved by the Sponsoring Body.

- 13.1 The procedure for the deposit of fees, delay fine, entry/deletion of the names from the rolls of the academic programs of the University in case of default students shall be circulated by the Dean of the School on the approval of the Vice-Chancellor.

- 13.3 The fee for different courses under the Schools will be notified in the Admission Notification in the website every Academic Year.
- 13.4 Further, Students are advised to see the fee circulars issued from time to time from respective Dean of the School.

## **14 Withdrawal Procedure**

Submission of '**No Dues Certificate**' is mandatory for withdrawal from the course of the University.

### **14.1 *Withdrawal before the commencement of the programme***

In case of withdrawal before the commencement of programme, the student has to submit request online. The refund shall be made as per the Provisions of Fee Refund Policy.

### ***Withdrawal after the commencement of the programme***

A student once enrolled for a course is expected to complete the same. He/ She cannot withdraw from the School of the University without informing the Registrar in writing.

A candidate who desires to leave the School after joining the programme will have to submit a '**No Dues Certificate**' from his / her respective school of study at MNRU to get back the certificates. This should be accompanied by the application for withdrawal duly signed by the Parent/Guardian and the original fee receipt and provisional admission letter (E-mail request will not be considered). The certificates will be issued only on production of '**No Dues Certificate**' in the prescribed form, obtained from the Admissions Office.

Last two years have taught us the importance of health-care professionals, who have acted as saviors for the entire mankind globally. Medical is one of the noblest professions and a booming career, because the demand for doctors or medical practitioners is never going to decrease. There are a number of medical courses which you can take up to enter the medical industry, one such course is Allied Health Science course. As the Ministry of Health and Family Welfare, Government of India gets ready to give a facelift to the entire allied health services by encouraging institutions to get started, MNR University extends its excellence by starting courses under the School of Allied Health Sciences so that skilled healthcare workforce can be generated to fulfill the present need of India in general and the state of Telangana in particular. The School is one of the few institutions in the state exclusively dedicated to the education of allied health professionals.

Allied health sciences deal with all sorts of medical diagnostic techniques (e.g. blood analysis, image technology, histopathology, pathological analysis, radiography) that are used in the medical field and are very relevant for patient care. The role of allied health workers in providing effective care has become critical with diagnosis based on technology. Some Bureaus of Statistics worldwide estimate that, relative to most other professions, healthcare-related careers are out for a higher growth rate. Over the last decade, advancements in technology have produced a dramatic change in the general viewpoint of the healthcare industry. The positions of paramedical practitioners and technologists are no longer considered to be the prerogative of physicians and nurses with greater significance. In addition, a greater range of opportunities are now available in higher-level studies and study areas related to Allied health services.

Job prospects for clinical laboratory technologists are likely to surpass the trained professionals available, as doctors rely more and more on diagnostic laboratory tests. The growing demand for surgical assistants and OT technologists is being increased by the use of surgical procedures for the treatment of diseases in an ageing population. In order to associate the

symptoms with the diagnosis and to treat the patient correctly, these individuals are actively interested in proper examination and diagnosis of the diseases.

MNR University being a multidisciplinary and research university with several Medical, Dental, Nursing, Physiotherapy, Pharmacy, Homoeopathy and Engineering & Technology Courses being offered in a single campus, it's students have an added advantage of having a better and useful interaction with other students, staff and facilities which will enhance their 21<sup>st</sup> century capabilities across the disciplines required in health care. The Faculty of MNR University comprises of senior and highly qualified teachers with decades of experience in service and teaching. The students gets excellent training in the central clinical laboratories, pathology, microbiology and bio-chemistry departments, radio diagnosis departments of medical and dental colleges in the campus. To fulfill the needs of comprehensive healthcare, the School of Allied Health Sciences offers the following courses.

- (1) B.Sc (Hons) (Medical Lab Technology)
- (2) B.Sc (Hons) (Anesthesiology Tech and OT)
- (3) B.Sc (Hons) (Radiology and Image Technology)
- (4) B.Sc (Hons) (Renal Dialysis Technology)
- (5) B.Sc (Hons) (Emergency Medical Technology)
- (6) B.Sc (Hons) (Respiratory Therapy Technology)

### **15.3 MNRU School of Physiotherapy**

MNR Sanjeevani College of Physiotherapy was established in 1999. It was a premier institute managed by MNR Educational Trust. It was affiliated with the NTR University of Health Sciences and recognized by AIPA and the Central Govt. of India and later to the KNR University of Health Sciences (KNRUHS). It is one of the first few colleges to offer a Bachelor of Physiotherapy (BPT) course in Telangana State. The Master of Physiotherapy (MPT) program was commenced in May 2006.

The college has departments like Anatomy, Physiology, Biochemistry, General Medicine, General Surgery, and Orthopaedics. The experienced faculty provides guidance and additional training sessions for students. Students expand their horizons of therapeutic and rehabilitation concepts through community-based rehabilitation programs and other "outreach" activities sponsored by the Govt. of India and other international agencies.

Innovative and current practices of teaching methodology are employed in the teaching of students. Apart from lectures by the faculty and guest lectures by eminent personalities, workshops are conducted to facilitate the students to gain the best possible knowledge and simultaneously develop their personalities.

Students receive training in manufacturing various aids and implements such as callipers, and artificial limbs, etc. at a well-equipped Orthotic & Prosthetic unit.

### **Special Initiatives**

‘Student mentoring program’ for first year students is used to benefit them by providing individual attention and counselling. Special care is also taken of those students who are lagging. Guidance is provided to the students regarding higher studies and opportunities abroad like the USA, UK, Australia, etc. Special seminars are arranged for students to enable them to prepare well for exams like TOEFL and GRE.

### **Infrastructure & Facilities**

Practical training is imparted to students in MNR teaching Hospitals located within the campus. Additionally, students are posted in Gandhi Hospital and other reputed institutions in Hyderabad, Telangana State to enable them to learn more and have exposure.

The institution has excellent infrastructure facilities, spacious lecture halls with good lighting, ventilation, and well-equipped audio-visual aids, spacious (8000 sq. ft.) central library with access to over 10,000 books and 100 Indian and foreign journals, textbooks, and reference books dedicated to Physiotherapy are available on the campus. A media centre attached to the central library has internet, reprography, and fax facilities among others.

There are two separate labs in the college, one for Kinesis therapeutics (Exercise Therapy) and Electro-Therapy. These labs have all physiotherapy equipment essential for demonstration and practice by students. A fully functional Physiotherapy Department present in the attached MNR Hospital provides both outpatient and inpatient physiotherapy services. It has all facilities including - Ultrasound therapy, SWD, TENS, IFT, Hydro-collator packs, Paraffin wax therapy, Traction, Exercise bicycle, Treadmill, Portable sports PT equipment, Massage, Manual therapy, etc. The College offers the following courses.

#### **15.3.1 Under Graduate Course**

- (1) Bachelor of Physiotherapy (BPT): Duration (4 ½ Years)

#### **15.3.2 Post Graduate Courses**

- (1) Master of Physiotherapy (MPT): Duration (2 Years)
- (2) MPT in Orthopedics
- (3) MPT in Neurology
- (4) MPT in Cardio vascular & Pulmonary

## **16 Number of Seats**

The number of intake for all courses will be decided by the Board of Management and Governing Body with ratification by the Sponsoring Body at the beginning of every academic Year.

The number of seats will be mentioned in the admission notification every year.

## 17 **Refund Policy**

The MNR University Fee Refund Policy for freshmen is based on UGC Guidelines and shall be effective with immediate effect.

### 17.1 **Procedure**

- 17.1.1 Any student admitted to any of the Courses offered by the University may apply for cancellation of his/her admission and/or for withdrawal from studies at any time during the academic year of admission or later.
- 17.1.2 Application form for Cancellation/Withdrawal must be made in the prescribed format duly signed by the student and the parent.
- 17.1.3 Application for cancellation of admission/withdrawal may be made either by applying along with the duly filled and signed prescribed format in person by the student or his/her authorized representative or by applying online.
- 17.1.4 The application of cancellation/withdrawal of admission, will be sent to Dean of respective school followed by Director (Admission) for their recommendation and will be finally approved by Registrar. However, this process should not take more than 05 days from the date of receipt of the withdrawal application.
- 17.1.5 On receiving the approval of the Registrar and after confirming the dues, the withdrawal/cancellation application will be forwarded to the Finance Department, and it shall process the refund of the fees as under

The last date of admissions shall be notified by the University. The University reserves the rights to change / alter these dates given the unprecedented times.

\* In case of (1) in the table above, the University shall deduct an amount of Rs. 5,000/- as processing charges from the **REFUNDABLE** amount.

\*\* Caution money, security deposit, tuition fee shall be refunded as per the above table. However, the one-time registration as applicable for the respective program shall be **NON-REFUNDABLE**.

- 17.1.6 Fees shall be refunded by the University to an eligible student within fifteen days from the date of receiving a written application from

him/her in this regard.

- 17.1.7 In case of scholarships being awarded to the student at the time of admission, and the student withdraws, then in such case, the scholarship will be lapsed and the fee refunded shall be calculated based on the full tuition fee without scholarship offered to the student, and in case of shortfall, the University shall have the right to collect the same amount from the student.
- 17.1.8 Refund of security deposit shall be subject to such deductions as may be necessary on account of any damage to the property of the Institution concerned such as breakages to laboratory equipment, assets such as computers, gadgets etc., loss of library books, or any other infrastructure of the University, for which the student would be responsible.
- 17.1.9 In case, admission of student is cancelled on account of disciplinary action or violation of Anti Ragging Regulations or Substance Abuse or breach of Code of Conduct or any other Rules & Regulations of the University, **NO REFUND of fees is permissible**. Only the respective deposits would be refunded to the student.
- 17.1.10 In case, admission of student is cancelled on account of ineligibility detected at any stage, **NO REFUND** of fees will be permissible.
- 17.1.11 If after getting registered for the Programme, candidate fails to produce documentary proof of minimum educational qualification by stipulated date given by the University or discrepancy is found between academic details furnished in the application form and the original documents submitted by the candidate, the admission shall be cancelled, and the fee deposited will be forfeited except the Security Deposit.
- 17.1.12 If any of the document(s) submitted by candidate to the University is found to be forged, fabricated or false during the period of his/her study or any instance of donation/unfair means is found after admission, the admission shall be cancelled immediately, fees shall be forfeited and legal proceeding may also be initiated.

**17.2 Transfer of fees for Admission to other School/Department of the University**

- 17.2.1 In case student applies for transfer of admission from one school/department of MNRU to another school/department of MNRU, the transfer application shall be processed and if approved by the University; the transfer of fees shall be as under
  - 17.2.1.1 If the student applies for transfer of admission to another school/department of MNRU before commencement of the programme then 100% fees shall be transferred.
  - 17.2.1.2 In case the programme fees are different, then the student will have to pay the difference in the fees or else the amount will be adjusted in the next instalment / refunded to the

student.

## 18 Maintenance of Discipline and Dress Code

- 18.1 Students shall maintain strict discipline during the period of study/Internship training program. They shall not resort to any strikes during the period of their study and stay in the University Campus. The students are not permitted in criticizing the policies of the Schools to which they belong or the University either before the print or electronic media. In case of violation of the same, the admission of the candidate is liable for cancellation apart from invoking the terms and conditions of the bond if any.
- 18.2 All powers relating to Discipline and Disciplinary action in relation to student/s shall vest in the Dean of the School and Dean of Students Welfare and The Vice-Chancellor is the Final Authority in this regard.
- 18.3 The Vice-Chancellor may, in the exercise of his powers, by order, direct that any student or students be expelled or rusticated, for a specified period, or be not admitted to a course or courses of study in Department or the School of the University for a stated period, or be punished with fine for an amount to be specified in the order, or be debarred from taking an examination or examinations conducted by the University or a Department or the School for one or more years, or that the results of the student or students concerned in the examination or examinations in which he or they have appeared be cancelled.
- 18.4 The Dean of the School/s, the Director of the Centre, the Chairman of the Board of Management, the Dean of Faculties, the Head of Departments, shall have the authority to exercise all such disciplinary powers over the students in their respective Centers, Schools, Faculties, and Departments as may be necessary for the proper conduct of such Centers, Schools, Faculties, Departments.

18.5 The Chairman of the Board of Management, The Dean of School/s/Faculties, the Director of the Centre, and Head of Departments may frame Additional Rules and such Supplementary Rules, as they may deem necessary.

18.6 At the time of admission, every student shall be required to sign a declaration to the effect that he submits himself to the disciplinary jurisdiction of the Vice-Chancellor and the other authorities of the University.

18.7 The student and parent shall execute a Joint Affidavit as Proforma (*Annexure-C*) on Rs.20/- Non-Judicial Stamp Paper. The Affidavit must be executed before the Oath Commissioner/Advocate/ Notary Public.

18.8 **Dress Code:** The students shall be compliant with Dress Code as prescribed by the University. As MNR University does not follow a common uniform for its students in Schools and other Institutions, guidelines will be issued from time to time in terms of Dress Code. In order to ensure “modesty” or “discipline” through correct and socially acceptable behavior and clothes representing Indian traditional and cultural values in the University campus, dress code among the staff and students is maintainable. The dress code while taking into account the geographic and weather conditions will give due importance to their diverse social, regional, cultural and class backgrounds. The university does not believe in policing regarding the dress code but at the same time it views very seriously any violation of dress code. For the University, both right to education and clothing are very important. All intersectional aspects will be considered while formulating the dress code. Any changes in the dress code policy will be notified in the website or through circulars. Any dress code violation noticed in the campus will attract fine as may be decided by the university and leads to further disciplinary action including denial of entry into the campus.

## **19 Ragging**

Ragging is prohibited in Educational Institutions and Universities in the State of Telangana. Students shall not involve in ragging which may lead to serious consequences including cancellation of seat and punishments as per the law. The parent must submit an Affidavit as per Proforma (*Annexure-‘A’*) duly executed on Rs.20/- Non-Judicial Stamp Paper. The Affidavit must be executed before the Oath Commissioner/Advocate/ Notary Public. Similarly, the student seeking Admission in MNR University must also submit an Affidavit as per Proforma at (*Annexure-‘B’*).

## **20 Grievance Redressal**

### **20.1 Students Grievance Redressal Committee (SGRC)**

The Vice-Chancellor may, in consultation with the Chancellor, appoint a Senior Teacher as the Dean of Students Welfare and a Grievances Redressal Committee to oversee the welfare of the students. The Vice-Chancellor may, likewise, appoint another teacher to assist the Dean in performance of his functions. The Dean of Students Welfare shall have the overall charge of all extra-mural activities of the students. He shall be assisted by such staff as may be deemed appropriate by the Vice-Chancellor.

### **20.2 Grievance or Complaints**

If any, from students shall be heard by the Dean of Students Welfare and he may make appropriate recommendations to the Vice-Chancellor. If the Vice-Chancellor is not satisfied with the recommendations of the Dean of Students Welfare, he may take the following further action.

### **20.3 Ombudsman**

The Vice-Chancellor in consultation with Chancellor, may appoint a person who has been a Judge not below the rank of a District Judge or a Retired Professor who has at least ten years’ experience as a Professor as Ombudsman and refer him the student compliant.

**PART-I**

We have read and understood the specified rules of MNR University, Fasalwadi, Sangareddy District Hostels given in the website and agree to obey them. We understand the **highlights of the rules** as follows

- (1) **On class days, all hostellers need to be inside the hostel by 8.00 PM. Attendance will be taken every evening.**
- (2) Hostellers are allowed to go out for shopping etc., ('outing') during day time on the days when the classes are not there ('no-class days') for 6 hours. The number of outings in a month will be decided by the University. On the No-class days, the in-time will be 6.00 PM.
- (3) **Hostellers are allowed to go on leave for one weekend in a month, with parents' approval and prior permission of the hostel authorities. The stay can be either at parents' home or an authorized local guardian's home. However, if the parent or authorized local guardian arrives in person at the hostel, the hosteller can go with them on leave any number of times in a month.**
- (4) Hostel is meant to facilitate studies. Therefore, **silence should be maintained especially from 9.00 PM to 6.00 AM.** Students should not disturb others in any manner like by conducting parties, playing music, talking loudly over mobile phones, etc.
- (5) **For security reasons, non-local students will not be permitted to stay as day boarders outside the campus, unless parent stays with them.**
- (6) Students should stay **only in the room allotted to them.** Staying in other rooms is not permitted.
- (7) Any physical / mental harassment towards fellow students including ragging, quarrelling, using abusive language and **violent behaviour** is prohibited.
- (8) **Smoking is strictly prohibited inside the Hostel premises and University campus.**
- (9) **Multi-Level Marketing (MLM) and gambling in any form including playing cards in the hostels is prohibited.**
- (10) **Students' found entering the University campus / Hostel premises under the influence of alcohol or induce others to consume alcohol, will be suspended for one semester. If a student is found consuming / possessing (even empty bottles) liquor inside the University / Hostel premises, the student will be suspended for one year.**
- (11) **If narcotics or related substances are found in any room, all the students staying in that room will be expelled from the University. Students who consume / trade / possess narcotics inside / outside the hostel shall be expelled from the University. Abuse of any chemicals is strictly prohibited.**
- (12) Anyone causing **damage** to hostel property will be **penalized** suitably.
- (13) Hostel students should **not bring any day-scholar or former students of the Institution at MNR Education Trust or any other Student or Person** inside the hostel

premises.

- (14) Hostellers are **not allowed** to keep any kind of **motor vehicles, both inside the hostel as well as nearby.**
- (15) Students in the hostel are not allowed to keep **air coolers, musical instruments, players, TV, electric iron box kettle, induction stove, immersion water heater or any other electrical equipment/gadgets.** Unauthorized possession will lead to confiscation of the goods and penalties. Cooking in the rooms is strictly not permitted.
- (16) Students are **personally responsible to safeguard their belongings.** Students are advised not to keep large amounts of cash (i.e. more than Rs. 3000/-) nor valuables like gold, costly wristwatch, expensive jewellery etc., in their rooms.
- (17) **First year students will not be permitted for outings without supervision, during the first three months of joining.**
- (18) Students will not be permitted to stay in the hostels during **vacation period**, unless they have academic assignments.
- (19) Students planning to stay back **during summer semester** at hostels should pay the summer semester fees. The existing hostellers are not permitted to stay outside during regular / summer semesters **unless the respective parents come and stay along with student outside the campus. The parents shall approach the hostel warden in person in this regard from time to time.**
- (20) Students will **not be permitted to stay outside the campus during the vacation period** unless they have academics assignments / internships **with the prior knowledge of the parents.**
- (21) **Punishments measures notified in the students' Code of Conduct** published in the University website.
